We hereby certify that the following amendments to the Declaration of Condominium of Siesta Gulf View, a Condominium, and Articles of Incorporation of Siesta Gulf View Condominium Association, Inc., a Florida not-for-profit corporation organized to operate and maintain Siesta Gulf View, a Condominium, Official Records Book 1369, Page 220, et seq., of the Public Records of Sarasota County, Florida, as amended, was duly adopted by the Association membership at the annual meeting of the Association held on NOVEMBER 4, 1993.

DECLARATION OF CONDOMINIUM

1. Article X(t) of the Declaration of Condominium is hereby amended as follows:

(t) No unit shall be leased or rented to any person or entity other than the unit owner for a period of less than ~~two~~ one (1) consecutive weeks month, and no unit shall be the subject of a change in occupancy more than ~~20~~ 12 times during each calendar year.

ARTICLES OF INCORPORATION

2. Article 5, paragraph 1 of the Articles of Incorporation is hereby amended as follows:

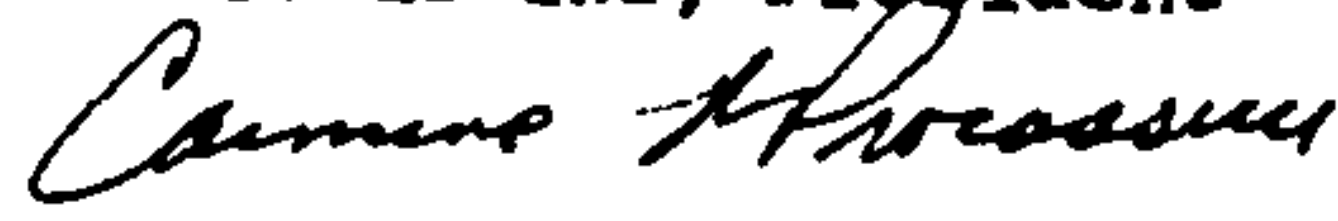
~~Paragraph 1. The affairs of the Association shall be managed by a Board consisting of the number of Directors determined by the Laws, but not less than three (3) Directors; and in the absence of such determination, shall consist of three (3) Directors. Directors need not to be members of the Association.~~

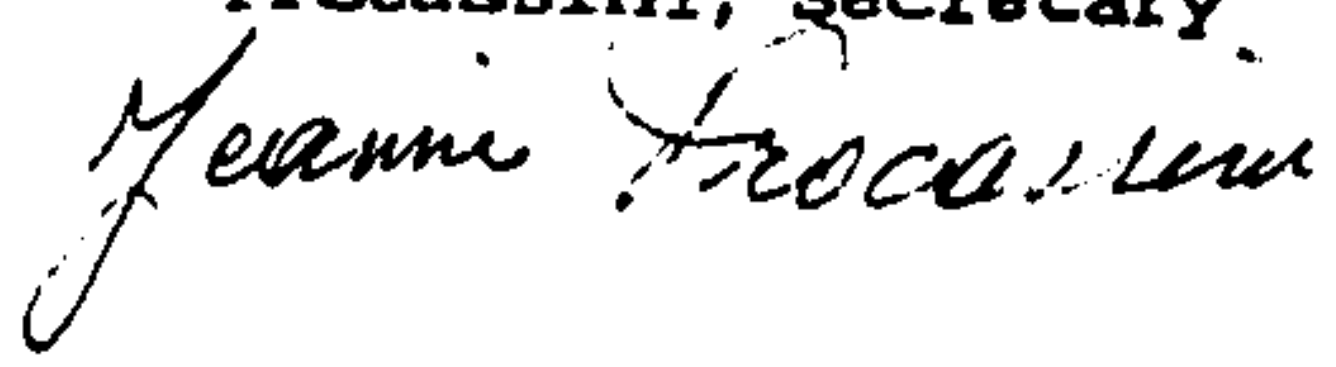

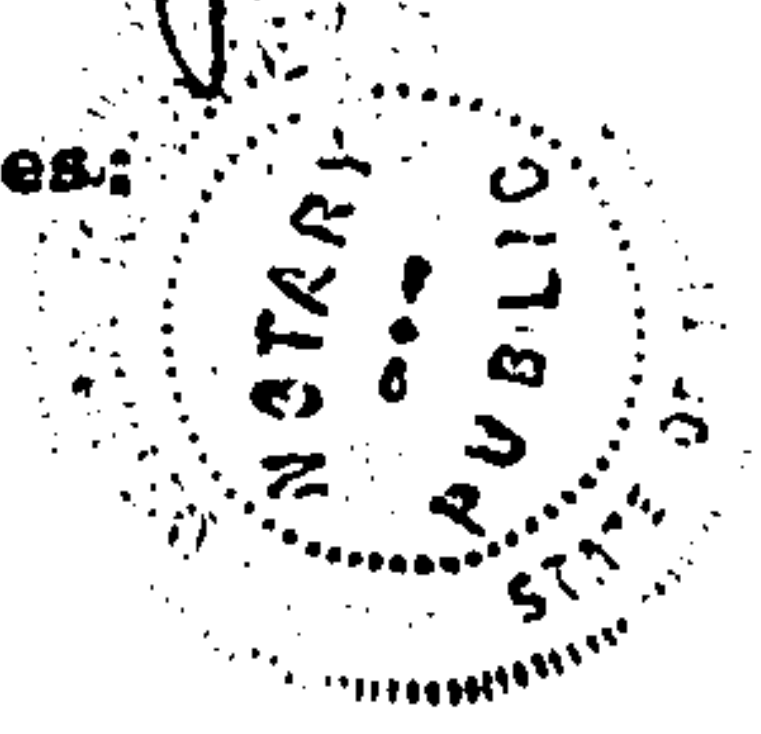

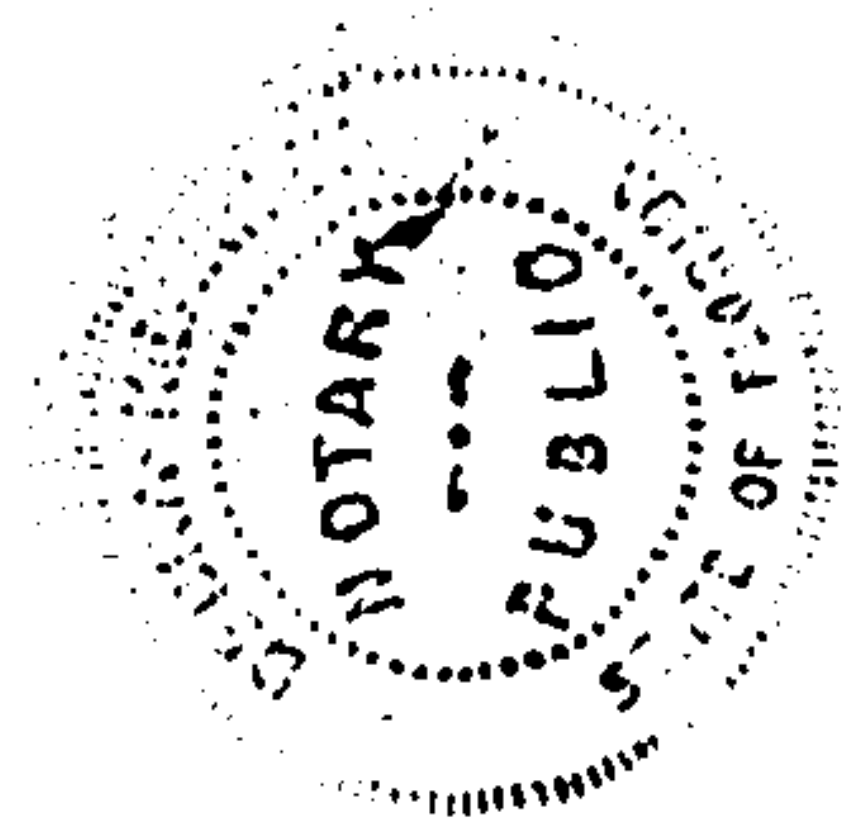
